## LOCAL ACTIONS

- The evacuation order and curfew order has been canceled.
- Points of Distribution have opened at the following locations:
  - St. Johns County Parks and Recreation office located at 2175 Mizell Road, St. Augustine, FL 32080 - hours of operation will be 0730 to 1900 daily.
  - Flagler Estates Road and Water District Office 9850 Light Avenue, Hastings, FL 32145 - hours of operation will be 0800 - 2000
- Urban Search and Rescue in conjunction with rapid damage assessment continue throughout the County.
- St. Johns County damage assessment teams are continuing preliminary damage assessment.
- St. Johns County road and bridge crews continue road clearing operations throughout the County.
- Bridges within the County are open.
- Due to significant damage, erosion, and debris, as a result of Hurricane Irma, St. Johns County is urging all residents and visitors to avoid the beach, beach access points, and walkovers until further notice. Swimming in the ocean is also discouraged due to high surf, rip currents, and debris.
- Churches and organizations assisting in clean-up from Hurricane Irma are encouraged to register online through Crisis Cleanup at [www.crisiscleanup.org](http://www.crisiscleanup.org). Residents can call the following number to request cleanup - 800-451-1954.
- For customers of St. Johns County solid waste services, the County has established temporary household garbage, recycling, and yard debris collection schedules in response to Hurricane Irma. All yard debris collections are cancelled through Friday, September 15. Please see below for the updated schedules:
  - Wednesday, September 13 - Residents who typically have household waste collection services on Monday, September 11 and Tuesday September 12 will have their garbage collected on Wednesday, September 13. Recycling collection has been suspended.

- Thursday, September 14 - Residents who typically have garbage collection services on Wednesday, September 13 and Thursday, September 14 will have their garbage collected on Thursday, September 14. Recycling collection services have been suspended.
- Friday, September 15 - Standard household waste and recycling collection schedules resume.
